

CALIFORNIA LEGISLATIVE SUMMARY – 2014 Alcohol Industry Continues Domination over Public Health

The alcohol industry in California has legislative power; the voices for public health have little power. Alcohol Justice monitored and took action on a total of 20 bills and resolutions of interest during California's 2014 Legislative session, a vast majority of which benefitted the alcohol industry. Of the 15 items that we opposed, 10 ultimately passed. Three of the bills we opposed died, and two were amended to remove the alcohol components. We supported 5 bills, 3 of which passed.

As in prior years, the California legislature and Governor Brown in 2014 favored the alcohol industry over public health. While none of the industry-friendly bills were sweeping in scope, the legislation favoring industry received alcohol industry juice to continue a sustained push to further erode regulation. The themes of the bills generally fit two categories:

(1) expanding what is permissible in a distinct area of policy; or(2) bringing parity between policy covering industry segments such as wine and beer.

Whatever the details of the legislation, the overall outcome remained the same: increased alcohol availability.

The 2014 session offered specific examples of this lock-step process of incremental change followed by parity resulting in increased alcohol availability. AB 2004 authorized beer manufacturers to receive certified farmers' market beer sales permits, and AB 2488 authorized wine licensees with certified farmers' market sales permits to conduct instructional tasting events at farmers' markets. Because state law already permitted wineries to sell wine at farmers' markets, the argument followed that each of these

changes were only incremental expansions of an existing policy. Yet, the cumulative outcome of these changes is further expansion of alcohol availability.

An alcohol-related bill with great potential to positively impact public health failed. SB 1663 would have required the CA Dept. of Alcoholic Beverage Control to prepare and submit a report to the Legislature regarding enforcement staffing levels for its district offices, and include recommendations on funding levels necessary to support appropriate enforcement staffing. While the bill would not have guaranteed additional funding for enforcement, it did reinforce the importance of enforcement.

California's alcohol-related legislative activity was not all negative in 2014. Two victories for public health were seen in AB 1928, which restricted types of coupons that retailers, manufacturers, and wholesalers may redeem and offer, and AB 2010, which imposed similar regulations on all tiers of the alcohol sales system with regard to duplicate licenses. Both of these bills were more technical in nature and focused on the relationship between tiers. However, while separate and distinct tiers are a foundation for sound alcohol policy, there was no legislation pushing back against increased availability at the retail level. In fact, AB 2010 also eliminated the current 30-day prohibition on sales that follows the issuance of a duplicate license.

Three resolutions approved in the 2014 session served as a point of contrast and illustrated the California legislature's incongruity on issues of alcohol and public health. Specifically, the Assembly and Senate chose to simultaneously observe awareness about alcohol-related harm and to promote the California alcohol industry within the same month. California legislators proclaimed April as Alcohol Awareness Month, Craft Brewery Month, and "California Wines: Down to Earth" month.
